

Influence and Advocacy Committee Update



Changes to the Kids Online Safety Act (KOSA)

Future Privacy Forum (FPF) recently shared information on the changes made in the <u>updated version</u> of the Kids Online Safety Act (KOSA), which aim to address concerns surrounding potential impacts on LGBTQ+ youth and online free speech.

You can view their <u>redline comparison of the two bills</u> with notable changes including clarifications on platform responsibilities for child safety, shifts in enforcement duties to the FTC, and the introduction of safeguards for children's data. These updates mark a significant step forward in online safety regulation, though challenges remain in the legislative process ahead.
